Regulations of the Best Student Paper Prize awarded during 4th Polish Law and Economics Conference

GENERAL INFORMATION

§1

- 1. The Best Students Paper Prize Competition (hereinafter: Competition) forms the part of the 4th Polish Law & Economics Conference (hereinafter: Conference).
- 2. The Competition is organized by:
 - a) Polish Association of Law and Economics,
 - b) Centre for Economic Analyses of Public Sector at Faculty of Economic Sciences, University of Warsaw,
 - c) Students' Association of Economic Analysis of Law, Warsaw School of Economics,
 - d) Students' Association of Law and Economics at Faculty of Law and Administration, University of Warsaw,
 - e) Students' Association of Institutional Economics, Faculty of Economic Sciences, University of Warsaw
- 3. The Conference will take place on October 23-24, 2015 at the Warsaw School of Economics.

§2

The aim of the Competition is to promote the developing interdisciplinary scientific movement of Law and Economics among students as well as to enrich their knowledge regarding the use of economic tools in enacting, applying, and teaching law.

- **§3**
- 1. Undergraduate and master students are eligible to participate in the Competition, regardless of the faculty and semester of studies.
- 2. To participate in the Competition, one shall have a student status (student ID card valid minimum to 31 October 2015.

THE COMPETITION

§1

- 1. To participate in the Competition, one shall submit an individually written paper concerning Law and Economics to studentpanel2015@pseap.org.
- The paper should contain not less than 10 and more than 15 pages (format: A4, font: Times New Roman 12 pt, standard margins).
- 3. If the paper has been published before, it should be noted where and when it was published.
- 4. The paper should be written in English.
- 5. At the moment of submitting the paper, the author should provide the following information: name and surname, university, faculty and semester, address, phone numer and e-mail address.
- 6. The submitted paper should be accompanied by an abstract (half a page long, subject to requirements from point 2). The abstract should state the main aim of the paper, basic hypotheses, applied methodology and the most important conclusions.
- 7. The submission deadline is October 12, 2015.

§5

- 1. From all submissions the Scientific Committee will select three papers for the award.
- 2. The results of the Competition will be announced on October 16, 2015 on the webpage of the Conference: www.lawandeconomics.pl.
- 3. The winners will be informed via e-mail or telephone.

THE PRIZES

§6

- 1. Authors of the three papers, mentioned in §5, will be rewarded with:
 - a) books prizes,
 - b) the possibility to present the submitted paper during the student panel of the Conference,

- c) the possibility to publish the submitted paper in the post-conference publication (*Polish Yearbook of Law & Economics*), if it is accepted for publication in an additional review process.
- 2. By participating in the Competition, the participants agree for presenting and publishing their paper as, mentioned in point 1b and 1c. The refusal to grant such consent will result in the withdrawal of the paper from the Competition.

FINAL PROVISIONS

§7

- 1. The Organizers reserve the right to reward a different number of participants than those listed in §6 as well as not to grant any reward.
- 2. The Organizers reserve the right to revoke the Competition, if such necessity will be caused by technical failure, final court judgment, an administrative decision, the change of law or force majeure within the meaning of civil law. The organizers will announce the revocation of the Competition by the means adapted for disseminating information about the Competition.

§8

The organizers reserve the right to change the Competition regulations. Changes will be binding from the moment of the publication on the Conference webpage.
